The Politics of Precarity and Cultures of Borders

#### Resumen de la Memoria:

Maribel Casas-Cortes developed university training internationally, conducting higher education studies in Spain, France, Canada and the United States. She has a consolidated research trajectory in the North American academy. M. Casas-Cortes has been residing and working in the United States since 2001, developing a solid record of publications, ongoing success in obtaining funding from US institutions, while having three maternity intervals. During this doctoral and post-doctoral period, she maintained a high-rate of academic activities in different countries, including ongoing participation in international research networks with top scholars at leading research centers. The candidate has been regularly publishing since 2007 in English and Spanish, with work translated into German, French and Italian. Maribel Casas-Cortes has been releasing an average of 3-4 peer-reviewed contributions annually since 2011. Currently she has a series of submitted, accepted and forthcoming publications showing her ongoing rate of productivity.

The candidate has 45 publications, 34 being peer-reviewed, and 23 having appeared in indexed international journals. Notably, this year she will reach a total of 10 article in Q1 journals. She has also contributed with 16 book chapters to volumes edited by respected international scholars and published in high-level presses including Duke University Press, Routledge, Wiley-Blackwell and Edward Elgar Press. She demonstrates a strong collaborative record of co-authored works within interdisciplinary research projects advancing innovative contributions to the respective fields. She is developing a growing collection of single authored works, including two articles in Q1 journals this year, as well as a monograph currently with editors at Duke University Press.

The candidate has delivered more than 45 oral communications, 26 at international scientific conferences, and several published as conference proceedings. Also, she has been invited to conduct around 20 public addresses at a series of universities, NGOs and art galleries at renowned museums. Besides publications and presentations for scholarly and non-specialized audiences, her research team has developed innovative tools, such as maps, to disseminate research findings including exhibits in art galleries internationally, including Los Angeles, Madrid and Zagreb.

Her record of fieldwork experience speaks to her ability to coordinate long-term research projects, plan research methodologies accordingly as well as adapt to diverse cultural contexts such as indigenous communities in Guatemala, activist circles in urban settings in Southern Europe and the US, high-end functionaries of the European Union in Brussels, as well as border authorities in Spain and Morocco.

Her successful funding record includes support from the National Science Foundation, the most prestigious public research institution in the US, and the Wenner-Gren Foundation, the most important source for Anthropological research support in the English speaking academy. The candidate maintains ongoing collaborations with an international network of scholars, thanks to her participation in interdisciplinary research groups based at UNC-Chapel Hill; Duke University; King's College of London; the Museum Reina Sofia in Madrid.

## Resumen del Currículum Vitae:

I have developed a solid international academic trajectory thanks to periods of education at high-ranked universities in Spain, France, Canada and the United States. Starting my university studies in Humanities at Universidad de Salamanca, I developed my interest in political cultures at the Institute of Etudes Politiques in Rennes and during my Masters at the Institute of Latin American Studies in Salamanca. My graduate studies continued at McGill University in Montreal and finally I obtained a PhD in Cultural Anthropology from the University of North Carolina at Chapel Hill. My record of awards, appointments and publications shows a consolidated presence in the North American academy working closely with internationally renown scholars such as Charles Taylor, Lawrence Grossberg, Walter Mignolo and Arturo Escobar among others.

My research is of an interdisciplinary nature within the Social Sciences, contributing to Social Anthropology and Cultural Geography as well as the burgeoning fields of Social Movements Studies and Migration Studies. I have developed two major research strands, on precarity as a single author, and on borders as leading a collaborative research project. For these research lines, I have earned competitive funds from high-ranked US institutions such as the American Council of Learned Societies and the governmental research agency, the National Science Foundation. All my funding comes from consolidated research institutions after merit-based selection in national and international competitions. Among my 45 publications, 34 are peer-reviewed, 23 have appeared in indexed international journals, out of which 10 are in the first quartile, and 16 are book chapters. My first book manuscript is currently under review with Duke University Press, thanks to a

fellowship awarded by the Wenner-Gren Foundation, the most well known institution for research in Anthropology. According to Academia.edu, my scholarly work has over 7,000 reads and is among the top 3%. My ResearchGate profile index is currently at 13.59, with 398 citations.

I regularly participate in professional conferences such as the American Anthropology Association, American Association of Geographers, the European Association of Social Anthropology and Congresos de Antropologia del Estado Espanol. I have been invited to conduct public addresses at centers of higher education internationally, with invitations to well-established universities in the UK, Netherlands, Germany, Italy, France, Spain, Greece, Argentina, El Salvador, Cuba and the US, where most recently I presented at Columbia University and Duke University. In fact, reflecting the increasing recognition of my scholarly work, I have been invited to act as a "peer-reviewer" in Q1 journals related to my research topics, including Security Dialogue, and the Journal of Migration and Ethnic Studies. Given my emphasis on collaborative research work and co-authored publications, I have developed a broad network of international research collaborators based in well-established universities in the US, Canada, the UK, the Netherlands, Spain, Italy and Germany. Simultaneously to my research, I have conducted Knowledge Transfer activities. Findings have been distributed to EU policy makers, US and Spain based NGOs as well as non-specialist audiences.

Gender studies and vulnerability, resilience and adaptation to global environmental change

#### Resumen de la Memoria:

I'm PhD in Environmental Science, option of Ecological Economics, for the University Autonomous of Barcelona and current researcher at the Universitat de Vic- Universitat Central de Catalunya.

During my PhD, I designed an anticipatory co-learning process for exploring the present and future for semi-arid socio-ecological systems in mountain protected areas of northern Nicaragua and understanding their vulnerability and adaptation pathways in the face of global environmental changes. My PhD field-work was realized in collaboration with the Universidad Autónoma de Nicaragua (Nicaragua) and I spent two years (2007-2008) living in the northern of Nicaragua, working with the communities of the Protected Landscape of Miraflores-Moropotente, and collaborating with national and international research institutes.

Through my academic and professional career, I have contributed to fill the gap between social and natural sciences research by conducting studies on agro-food systems as complex adaptive social-ecological systems and exploring traditional and local knowledge, practices and institutions that regulate natural resource management. My research experience and work in collaboration with communities and grassroots organizations has been influencing my transdisciplinary profile, pushing me to explore out of the box on how integrating focus and methods from the social and natural sciences (and arts) as well as from scientific and local/indigenous knowledge systems to study the vulnerability and adaptation of rural agro-food systems to global change.

In 2017 I received a prestigious AXA Fellowship with the project AGATA Agrifood systems, Gender And Transformational Adaptation: a systemic and intersectional approach applied in Mediterranean context . In the same line of research, recently, I ve obtained the funding for a new research from a Gender-ERANET call on Gender and Climate Change (SEQUAL project 2019-2021).

I plan to advance the understanding of social-ecological systems and transformative adaptation towards sustainability through analyzing socio-institutional innovations, collective actions and the role of traditional and local knowledge in responding to global environmental challenges (including climate change), especially in agricultural and (silvo) pastoral systems of high mountain regions. Through a perspective of feminist political ecology applied to studies of adaptation and resilience, my research is oriented to understand the dynamics of power that create inequalities, and the differential conditions that create new opportunities in the transformations of social-ecological rural systems. I m also interested in exploring innovative methods to boost their interest in science in order to build a knowledge-based society able to deal with current social-ecological challenges.

# Resumen del Currículum Vitae:

Bachelor in Classical Literature, I moved then to Environmental Sciences linking social and ecological dimensions for investigating global change and I obtained my Degree from the University of Milano Bicocca, Italy. I have two master degree in Economic Development from the IUSS, Universitá degli Studi di Pavia, and in Ecological Economics from the Autonomous University of Barcelona. In 2011, I obtained my PhD from the Autonomous University of Barcelona, in the area of expertise of Ecological Economics. In 2016 I obtained a two-year Juan de la Cierva fellowship and I started working with the Chair in Agroecology and Food System at the Universitat de Vic - Universitat Central de Catalunya.

I have held research stays at the Sustainability Research Institute, University of Leeds (UK) (2009) with a pre-doctoral fellowship Marie-Curie Slodovoska, and the Institute of Agricultural and Environmental Sciences of the Mediterranean (ICAAM), University of Evora (Portugal) (2015-2017), as the postdoctoral researcher. I have also been a two-years postdoctoral researcher at the Autonomous University of Madrid (2013-2015) and at the Basque Center for Climate Change in the Basque Country (2012). Since 2015, I have been participating in the group of experts of the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES).

I have co-authored 33 publications, 12 of them as lead author. They include 16 articles in peer-reviewed journals of Q1 and 4 articles of Q2 Environmental and Social Science SJR, 3 articles in Spanish peer-review journals, 1 article in an Italian peer-review journal, 1 entry of the International Encyclopedia of Geography: People, the Earth, Environment and Technology and 8 book chapters and reports of international distribution. I was co-editor of three special issues for AMBIO, Environment, Development and Sustainability, and Sustainability. I have

Women's education and couples' allocation of time

#### Resumen de la Memoria:

Since 1999, I have worked in demography and population studies. My research has developed on the base of solid knowledge and management of census and survey data sources that I have learned during my work at the Centre d Estudis Demogràfics (CED) and the Minnesota Population Center (MPC). Although during the first years of my research I mainly worked on technical aspects, since I started my PhD in 2008 I have established my own career that covers a large number of fields of demography, including family formation and the use of time by individuals and couples. My research has been published in the most prestigious journals on demographic research and population studies, including eight publications in first quartile JCR journals (eleven in Scopus).

In 2012, I completed my PhD entitled El uso del tiempo en las parejas de doble ingreso. I studied time allocation in dual earner couples, and I started to use data from time use surveys. During my PhD I also worked simultaneously on the project Towards a Unified Analysis of World Population: Family Patterns in Multilevel Perspective (WORLDFAM). One of the aspects I explored in the framework of this project was the consequences of the reversal in gender gap, which is a crucial aspect in my main line of research.

In 2013, I started at the MPC as a Research Associate in the IPUMS Time Use project. At the MPC, I contributed to the management and updating of the databases and Extract builders to disseminate contemporary and historical time use data for the United States and other countries. In conjunction with my work on the microdata dissemination projects, I continued my own research on the allocation of time within couples and other research on family dynamics, such as couples shared time.

In January 2017, I came back to the CED thanks to the funding provided by the distinguished Juan de la Cierva Incorporación research program grant by the Ministerio de Educación Ciencia y Competitividad.

In January 2018, I started my own research project, entitled Implications of the gender gap in education between spouses in family life, thanks to the funding provided by the Beatriu de Pinós programme grants for the incorporation of postdoctoral research staff into the Catalan science and technology system by the Agència Catalana d Ajuts a la Recerca (AGAUR). In 2018, I received "la Caixa" Social Observatory Award for the best article in the field of Social Inclusion for my study "How are household chores divided in female breadwinner couples?"

The main line of research that I have carried out and that I expect to continue in the following years is well-summarized by the topic of my current fellowship: The better social status and higher human capital of women (more participation in labour market, higher education) has an impact on union formation and is reflected in new patterns of associative mating, division of gender roles in the couple and decision making. However, higher status does not always mean changes in the aspects described. In that sense, there are specificities at cultural, institutional or political levels that impede the adoption of new patterns of union formation, more equal gender roles in relationships or substantial changes in decision making.

Título:

Context matters: how geography affects political behaviour and public spending

#### Resumen de la Memoria:

My research to the date has been developed at the intersection between comparative political economy and electoral behavior. In particular, my research trajectory has explored how citizens political behavior varies across different regional contexts-, and how this, in turn, affects governments expenditure decisions. In doing this, a defining trait of my empirical methods is the combination of observational data, survey experiments, and quasi-experimental methods. In my research, I give strong importance to methodological rigor and the analysis of causality.

My research has shown that we cannot understand citizens political behavior and governments spending decisions if we do not account for the conditions, either economic or institutional, that they confront in their closest environment. On the one hand, I have studied how economic crises encourage more regionally-based voting (see my 2017 European Journal of Political Research article), how different levels of decentralization affect citizens capacity to attribute responsibilities for policy outcomes and vote accordingly (see my 2018 West European Politics article), and how district magnitude of the different Spanish provinces conditions strategic voting and abstention (in my 2015 Party Politics publication). On the other hand, I have explored how regional dynamics provide incentives to governments to shape their distributive strategies differently. Bringing the geography in to explain governments expenditure decisions is an original contribution of my work to an area of research that, until recently, has been virtually inexistent. I have shown how electoral geography has a direct impact on social spending (see my 2014 European Journal of Political Research article) as well as an interactive effect with electoral systems (see my 2017 article in the British Journal of Political Science).

At present, I am extending my research to explore the impact of the international context upon citizens political behavior. My main research line for the next academic years is to analyze how public opinion, voting and political preferences are shaped in an era of increasing globalization and economic integration and how this affects political processes. I am interested in how the traditional models of voting and preference formation are challenged by a new world context in which we are witnessing fast and dramatic changes driven by increasing economic and political integration. My goal is to provide a better understanding on how citizens engage in the political process when governments have increasingly less capacity to respond to voters demands and to provide clues to understand political transformations in our societies. This new line of research has already generated a publication in the journal International Organization, recognized as the top journal in International Relations.

#### Resumen del Currículum Vitae:

I received my D.Phil. in Politics at the University of Oxford (Nuffield College) in July 2012. My thesis was awarded with the PSA s Arthur McDougall Fund Prize to the 2012 best British dissertation in Elections, Electoral Systems and Representation. Part of my doctoral research was conducted at Princeton University during the 2009-2010 academic year. Before that, I completed a Specialization Degree in Advanced Methods of Applied Statistics (UNED) in 2009, as well as a Master of Arts in Social Sciences at the Juan March Institute in 2007.

My trajectory to the date has yielded 23 publications: 15 journal articles, 6 book chapters, a collective book and a policy report. 10 of my articles have been published in journals that belong to the first quartile of the JCR. In particular, I have published in journals that are commonly recognized as outstanding such as one article in International Organization, an article in the British Journal of Political Science, or two articles in European Journal of Political Research, among others.

I have participated in numerous collaborative research projects, funded by a variety of institutions. I am the Principal Investigator of the project Democratic Dissatisfaction in Southern Europe , funded with 254,000 by the Economic and Social Research Council (ESRC). In total, I have participated in projects that have raised 563,771 in external funding. In four of the projects I have been the Principal Investigator.

I have been involved in seven Phd supervisions and many MA dissertation supervisions. I have also been a regular attendant to international conferences and have an extensive record of invited talks in prestigious academic centers such as the Universities of Princeton, Lisbon, Zurich, Mannheim, Sheffield, Newcastle, Barcelona, Complutense, and Instituto de Políticas y Bienes Públicos. I have also consolidated my research networks with research stays in the Universities of Princeton, Mannheim, and Carlos III. I believe all this shows

Causes and Consequences of Conspiracy Theories

#### Resumen de la Memoria:

I am a political sociologist working on ethnic and religious hostility. My main line of research focuses on the causes and consequences of conspiracy theories.

I completed a BSc in Sociology (2002) and an MSc in Political Science (2005) at the Middle East Technical University, Turkey. Then, in 2010, I completed a PhD in Sociology at the University of Kent at Canterbury. My doctoral thesis examined the social significance of popular anti-Semitic conspiracy rhetoric in Turkey. The study received the first prize in the Doctoral Researcher Competition of the Association of British Turkish Academics in 2012.

Subsequently, I have won various grants for my own research projects, i.e. as a principle investigator, and worked at Freiburg University (2011-2012), Cambridge University (2015) and University of Oxford (2012-). During this period, which includes a career break of 30 months, I have expanded my research and developed an international reputation. The grants came from various sources, including but not limited to Economic and Social Research Council (ESRC), A. G. Leventis Foundation, International Center for the Study of Anti-Semitism, Calouste Gulbenkian Foundation (with two distinct projects), Rothschild Foundation, The Scientific and Technological Research Council of Turkey (TUBITAK) and University of Oxford.

First, the TUBITAK grant allowed me to work on the online communication of conspiracy theories in Turkey and Taiwan. Second, the grant from the International Centre for the Study of Anti-Semitism enabled to conduct research on online anti-Semitism in Turkey. Third, I was awarded a Rothschild Foundation grant and worked on the contemporary experience of the Jewish minority in Turkey. Fourth, I won a grant at the Freiburg University to conduct research about Emile Durkheim s influence on Turkish nationalism. Fifth, I am conducting research on the perception of Armenians in modern Turkish politics (1946–1980), funded by the Gulbenkian Foundation. Sixth, I am awarded a two-year grant from the Leventis Foundation to study the perception of the Greek minority in Turkish politics. Last, I have secured another grant from the Gulbenkian Foundation to study the impacts of the perception of Armenians in Turkey (1980–2018).

In the age of fake news, conspiracy theories continue to influence politics and society all around the world, and we still do not have sufficient evidence to understand their causes and impacts. To respond to this gap, with Professor Karen Douglas (Psychology Department, University of Kent), Dr Ozan Aksoy (Quantitative Social Sciences, University College London) and Dr Jonathan Bright (Oxford Internet Institute, University of Oxford), I designed an ambitious five-year research project on the political, social and psychological causes and impacts of conspiracy theories. I request Ramon y Cajal funding to be able to conduct this ground-breaking study, which will have a comparative section on Turkish and Spanish politics.

#### Details

I have published my work in top academic journals in Sociology, Psychology, Political Science and Area Studies, as book chapters in edited volumes by prominent academic publishers, such as Oxford University Press and in a book by Palgrave MacMillan.

I have published 11 single-authored and 1 co-authored articles in SSCI journals, an excellent indicator of my research independence. These articles were published in 12 distinct journals, which not only shows the versatility of my research profile but also the acceptance of my work by a great range of approaches. In parallel, these studies relied both qualitative and quantitative methods, and three of my articles were solely theoretical. Besides, I have two articles under review of Journal of Ethnic and Migration Studies and The Sociological Review. All in all, my research background shows an ability to use various methods and theories effectively towards high-quality publications.

Second, I have obtained various highly competitive research grants from various universities, research agencies and foundations, including University of Oxford, Rothschild Foundation, Gulbenkian Foundation, The Scientific and Technological Research Council of Turkey (TUBITAK), International Centre for the Study of Anti-Semitism, University of Freiburg, University of Cambridge.

My research includes international collaborations. First, I participate in a European Consortium of Research on Conspiracy Theories, Comparative Approaches to Conspiracy Theory. I am working on two articles with colleagues from Spain and Turkey. Socioeconomics of Cultural Heritage: Tradition, Quality & Innovation

#### Resumen de la Memoria:

My field of specialization within Sociology is Innovation Studies applied to the field of Cultural Heritage with an international scope in four interrelated strands:

The first examines the Socioeconomics of Cultural Heritage in Europe with a focus on the global economic crisis and business opportunities, an innovative research strand beginning with my PhD at Incipit-CSIC (Spain). The strategic importance of my seminal work resulted in a knowledge transfer-oriented database registered by CSIC, my involvement in 14 Spanish and 3 EU projects, and publications in ISI-Q1 indexed journals such as Journal of Business Research (2016), a monograph with USC Press and an international book chapter for the European Commission. My seminal work has been acknowledged in the prestigious journal Science, in the framework of a specialized report in 2012. I was invited twice as keynote speaker to inaugurate an international and a professional oriented congress.

A second research strand addresses Social Value and Tourism Sustainability at World Heritage Sites (WHS). I was responsible for the sociological assessment of the socioeconomic impact of Camino de Santiago for the R&D Galician Government Plan (2012) and also performed a leading role in the assessment of the potential social problems associated with the re-opening of the UNESCO Altamira WHS, in the framework of the Research Program for Preventive Conservation and Access Regime for the Altamira Cave (2012-2014) , supported by the Spanish Cultural Heritage Institute. My work in this field has been disseminated in leading ISI-Q1 journals like Annals of Tourism Research and in international book chapters edited by Springer and Gorgias Press.

Third, my work continued advancing the theoretical aspects of Innovation in the Cultural Economy and in Latin America during 2014-2016, when I coordinated a R&D competitive project funded by the Technical U. of Ambato (Ecuador), endowed with 81,739, entitled Models of Valuation and Sustainability of Cultural Heritage in Ecuador. This research period implied a globally relevant shift of my research line. I published in leading ISI-Q1 journals such as Journal of Ethnic and Migration Studies and started my supervising experience with a PhD at the U. of La Plata (Argentina) and 4 BA dissertations in Ecuador. These results were acknowledged in Europe: I was invited to become part of international assessment committees, including the European Commission for the evaluation of H2020 Projects, the R&D plans of Kazakhstan and Argentina, RIVAR Journal, Estrategias and becoming Subdirector of RELASO Journal.

More recently, my international postdoctoral position (2016-2018) has allowed me to further develop my research abilities and scope, focusing now on Tradition, Quality and Differentiation in Atlantic Wines. This reorientation has reinforced my international profile with a prolific ISI-Q1 publication record in Journal of Rural Studies, Land Use Policy, Cultural Geographies, Geoforum, Human Ecology and Renewable Agriculture and Food Systems. The viability of this research line has resulted in an agreement between the UDC and the Wine Denomination of Origin La Palma for the development of a R&D non-competitive project entitled Typification of Tea Wines: Aromatic Precursors and Chemical Composition (2018) , which I lead, coordinating a multidisciplinary research team.

# Resumen del Currículum Vitae:

I hold a three-year postdoctoral position (2016-2018), comprising two years of international stays at the Nova U. Lisbon and the ISCTE-University Institute of Lisbon (Portugal), and a return year at the U. Coruña (UDC), funded by the R&D Galician Government Plan (Spain). My training consists on a 5-year BA in Sociology (UDC,2005) and a European PhD in Economics (USC,2011) supported by a competitive Spanish predoctoral scholarship from CSIC (I3P-2006). The publication of my PhD by the USC Press has opened a hitherto unexplored area of debate both in Spain and abroad. It also allowed me to produce more than 20 indexed papers (13-ISI/18-SJR), 10 ISI-Q1 in top-level academic journals (Annals of Tourism Research, Land Use Policy, Journal of Rural Studies, Cultural Geographies or Journal of Ethnic and Migration Studies), 5-monographs, 8-book chapters and develop a knowledge-transfer oriented trajectory, including the intellectual propriety of the first Spanish Archaeology Companies Database, registered by CSIC that underpinned the research of other scholars and 9 scientific technical reports in open access. The prestigious journal Science acknowledged my work in 2012. Medición de la investigación en el contexto de la Open Science

#### Resumen de la Memoria:

El campo de trabajo y formación de la candidata es la cienciometría. En este ámbito comenzó su experiencia laboral en centros de in investigación de Argentina. La especialización hacia los estudios bibliométricos se logró a partir de la vinculación con el Centro de Información y Documentación Científica (CINDOC) del CSIC y continúo en el Laboratorio de Estudios Métricos de la Información (LEMI) de la Universidad Carlos III de Madrid (donde obtuvo un contrato Juan de la Cierva ) y posteriormente en el Instituto INAECU (centro mixto Uc3M-UAM). La experiencia obtenida en el Centre for Organizational Research de la Università della Svizzera Italiana (Suiza), donde trabajó como investigadora postdoctoral, le ha brindado una nueva perspectiva especialmente en cuanto al desarrollo metodológico.

Dentro del ámbito de la cienciometría ha desarrollado estudios sobre: evaluación institucional; colaboración científica; movilidad; ciencia, tecnología y género; y ránkings de universidades. Ha indagado también en la aplicación de la bibliometría para la detección de campos emergentes, frentes de investigación y análisis de comunidades bibliográficas en diferentes disciplinas.

La participación en proyectos nacionales e internacionales ha llevado a la candidata a lograr una importante especialización, lo que le ha permitido coordinar las actividades del equipo de trabajo del LEMI (UC3M) para la realización de diferentes informes, contratos de consultoría y proyectos de investigación. Asimismo, coordina las actividades del Observatorio IUNE y se encarga de la dirección de becarios y supervisión de las estancias de investigadores extranjeros. Dicho proyecto (solicitado como IP a la convocatoria RETOS), se encuentra en evaluación y cuenta con la participación de un equipo integrado por 15 investigadores (6 internacionales), especialistas, tanto en el ámbito de la evaluación de la ciencia como de la Open Science.

A futuro, la candidata, prevé seguir desarrollando la línea de indicadores cienciométricos pero centrándose en el diseño de nuevas metodologías para el análisis y evaluación de la actividad investigadora en el marco de la OS. En este contexto, el diseño de indicadores y metodologías, se presenta como un interesante desafío tanto a nivel nacional como internacional (con especial aplicación en las instituciones del Sistema de Educación Superior).
